Stages makes plays and tells stories that invite everyone to live more deeply and love more boldly. We hold up a mirror to our community in order to crack open the question: "What does it mean to be human?"

Form 990, Part VI, Section A, line 1a:

The Executive Committee consists of all of the officers of Stages, the Standing Committee Chairs, the Artistic Director, the Managing Director, and not more than four at-large Directors appointed by the Executive Committee. The Executive Committee may have a minimum of five members and a maximum of twelve members. Only Directors of the Company are voting members. The Artistic Director, Managing Director and other non-Director officers participate as non-voting members.

More than three absences annually without substitute with proxy attending may result in the individual's removal from the Executive Committee. The Executive Committee functions as the governing body of Stages but must seek approval of the Board of Directors for the budget, officer and director elections, and Bylaw changes, which are solely the responsibility of the Board of Directors. All other decisions made by the Executive Committee are binding to Stages. The Executive Committee members are appointed for a two year term that is renewable one time. A non-officer Executive Committee member may take an officer position after serving up to two consecutive terms in a non-officer role on the Executive Committee.
